MERCY FLIGHT SOUTHEAST INC IS A NON-PROFIT VOLUNTEER PILOT ORGANIZATION INVOLVED IN PUBLIC BENEFIT FLYING, ARRANGING FREE AIR TRANSPORTATION BY PRIVATE AIRCRAFT TO DISTANT MEDICAL FACILITIES WHEN COMMERCIAL SERVICE IS NOT AVAILABLE, IMPRACTICAL OR SIMPLY NOT AFFORDABLE. IN 2011, A TOTAL OF 792 SUPPORT MISSIONS WERE FLOWN, AND 1,246 MISSIONS WERE COORDINATED IN OUR AREA.
